Notes for Application for Approval of Project Presentation Arrangements

- 1. Application should be submitted to respective Faculty office after 3 months form the date of submission of the project proposal.
- 2. Before submitting this form, application must be first obtained the approval from supervisor with signature.
- 3. Candidates should submit this form and an electronic copy of the project report (MS Word or PDF Format) in person to respective Faculty office. Mainland students are required to submit a signed "Declaration Form for submitting of thesis for examination/ project presentation arrangements (For Mainland Chinese Students Only) (GS-10b)" together with this form.
- 4. Applications will be processed upon receipt of the completed application form and supporting documents.
- 5. If candidates do not submit the project report which is fulfilled the requirements for formatting during the normal study period, candidates should pay the related deferral administration fees and submit the project report before the date of deadline for project report submission at next semester. If project report submission is not done during the prescribed maximum period of study, it should be regarded as not completed the procedures of project presentation, candidates' studies shall be terminated.
- 6. The second project presentation fee once paid are not refundable or transferable.
- 7. Statement of Personal Data Collection: The personal data provided in this form will be used by the University for the purpose of processing this application.
